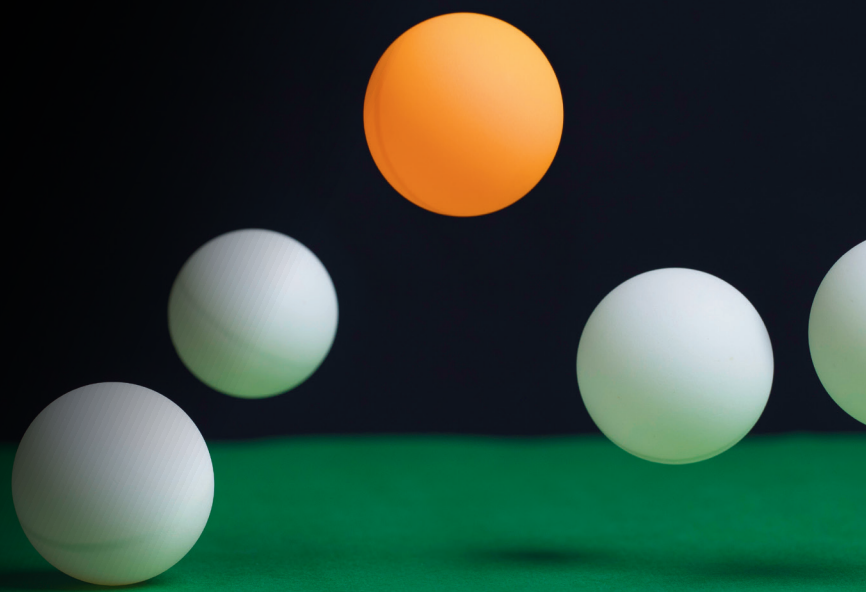

### Pathway to completing the CFF credential

Your staff who complete the self-study online education and pass the exams for the Core Forensic Accounting Certificate and the Specialized Forensic Accounting Certificate will fulfill the education and exam requirements of the CFF credential. That saves 16 CPE hours vs. not using these programs. (The CFF Credential has a 75-hour education requirement.)

**Note:** Earning both the Core and Specialized Forensic Accounting Certificates does not indicate credentialization in financial forensics.
