- Within your firm
- From your graduating class
- Among friends studying for the exam
- Through a young member group at your state CPA society
- Among other students in your review course
- In accounting-related social media groups (or use social media to find others to join a group you've started) like the American Institute of CPAs' [ThisWayToCPA](#) and [CPACandidate](#) groups on LinkedIn

# Establish study group guidelines.

These can be informal, but setting down some basic ground rules will enhance the group's effectiveness – and your future exam success! Here are some example guidelines you may want to consider:

- **How much time is each person willing to commit?** Will you meet at a set time or will you decide meeting times as you go?
- **What will be the format of the study group?** Will it be in-person or virtual? If in person, where will you meet? You'll need somewhere with plenty of space and no distractions.
- **What content will you use for your review?** For example, the AICPA's Examination [Blueprints](#) offer a comprehensive review of test content in all four sections of the exam. Sample tests are also available. The Blueprints and other resources can be found on the AICPA CPA Exam [site](#).
- **How will content be covered?** Will the group answer study questions, have an open discussion of study group members' concerns or some of both?
- **Will you limit the number of members?**
- **What will be expected of each study group member in between each session?** Establish goals that ensure group members are moving forward at the same rate but ones that are realistic given other time commitments.
- **Should you "set it in stone?"** Some groups work together to develop covenants. These guidelines help establish 5–7 "rules" of the group and can help members resolve potential conflicts.

# Be a good study buddy.

- Come prepared and ready to get to work.
- Commit to helping others succeed as they help you.
- Show up and be present.
- It can be tempting to get distracted by personal conversations during study time. Set aside a specific, short timeframe for socializing or make plans to socialize outside the group.
